Mayor George Steele took the floor and recommended that we go back and pay the Carter County Public Library for the first 2 quarters and continue to pay them for the rest of the fiscal year. He stated that the banks had loaned the library monies on the understanding that we pay the agreed upon amounts as did Olive Hill and the County. He believes they will struggle to pay these loans back without the funds that the city had contracted to pay. He suggested the city pay the 2 quarters that we already owe at one time then pay the other quarters as they come due. Mayor also recommended the council to take this before the Fiscal Court and ask for them to get this on the ballot to add a county library tax to fund the library.

Motion to approve the Mayors recommendations and pay the 2 quarters the city owes in the amount of \$12,500 then pay the \$6,250 in January and \$6,250 in March to complete the contract.




