Building Inspector Issue

Mayor Steele presented 3 options to the council on this issue.

Option One — Hire the gentleman from Florida 1 day a week. This gentleman would have to become certified in the state of Kentucky. He can only work 1 day a week.

Option Two — Hire a county resident who could work 3 days a week. Once he becomes certified in the state of Kentucky, the City would pay his single plan health insurance. At 24 hrs a week, he would also qualify for CERS retirement.

Option Three—Speak with a neighboring county Building Inspector, splitting the building fees 50/50.

Motion: To call gentleman from Greenup, to work one day a week, keeping him in that position until a building inspector can be hired at 24 hours a week. This option is offered to him as well. He would also need to be available in the evenings to meet with contractors, compensating his mileage provided he can do residential and commercial or someone to sign off on commercial inspections.


