Lewis Dixon and Todd Williams-notification app

Mr. Dixon and Mr. Williams gave a presentation to the Council about a phone app they have developed that has push notifications that could be used to promote City events or make announcements by sending notifications to anyone who downloads the app. There would be an initial fee of \$4,000 for the first year. Every year after that would be \$1,000 to continue to host the site. There would be no hidden costs. It would take approximately 45-60 days to get started and they would develop the app for us.

Joanne Dunfee presented an update on the Grant for the push notification app that was presented at last month's meeting by Bit Source. The cost for it was going to be around \$10,000 and we would have to set it up ourselves. The annual fee would be around 6 or 7 thousand dollars.

Concerning the cdp.mapsync app presented tonight, Roger Dunfee offered to put \$1000 in their budget to help pay for the app and to talk with Chamber of Commerce to see if they would want to put in \$2,000 to partner with us.

Councilman Duane Suttles stated he would like to do it, but he suggests to hold off till the next meeting and let Jason look over the sample contract they will be sending us.

Sidney Foster -5-K run

Sidney Foster representing student athletes from KCU. They want to partner with NECCO foster care to take a child for the day and have activities for them. They would like to sponsor a 5K run on April 18, 2020 to help pay for this event. She will meet with Chief McDavid to see what City streets need to be closed for this event.




